Roll call: Ayes: Kartak, Wilcox, Forgey, Jorgensen and Novotny. Nays: None. Resolution adopted.

Don Sabol came to the meeting to address some concerns he has about the wood plank bridge's safety South of his place by the four-mile corner. The planks get replaced but the stringers are so bad the planks do not last. He is asking the commissioners to consider putting some sort of culverts in and take out the bridge. He has cleaned out debris from under the bridge three times to help the county keep the bridge in working order. There is a lot of heavy machinery that goes over the bridge and with the stringers being bad it just breaks the planks. Mr. Sabol has been waiting to put up his new fence until something is done with the bridge as he knows it would have to be removed in order to access the bridge. Mr. Sabol would like to make this a priority because of the safety issue it causes with the missing and broken planks. Mr. Novotny explained a box culvert would be too expensive, but tube culverts are an option.

Roger Sund, Highway Superintendent, entered the meeting to give his report. Mr. Sund was informed about the bridge and is aware that it is a problem and needs to be fixed. Structure 61-191-320 has already had the specifications done and recommendations sent to Mr. Sund. They recommend (quadruple 96") (triple 108") (double 148"). The highway shop has two 10 ft pipes and one 8 ft pipe on hand that would work according to the specifications needed for this project. They will make this a priority and the work should take 5-6 days to complete.

Crews are reshaping the road on project 58, blading roads and graveling two miles on project 47. The highway crew is starting to repair signs damaged by the snow fall we received this winter.

Mr. Sund brought in the 2023 County Striping Agreement to be signed along with SPR Funded Planning Study Reimbursement Contract and the Brosz Engineering work order for the 2023 Bridge Inspections to be signed.

Forgey made the motion, seconded by Novotny, to give the Chair permission to sign the Pavement Marking Agreement for striping approximately 19.4 miles of Tripp County roads at an estimated cost of \$3,416.82.

Roll call: All ayes. Motion carried.

Forgey made the motion, seconded by Wilcox, to give the Chair permission to sign the SPR Fund Planning Study Reimbursement Contract in the amount of \$40,000.00. Roll call: All ayes. Motion carried.

Forgey made the motion, seconded by Jorgensen, to give the Chair permission to sign the Brosz Engineering, Inc. work order for 63 Bridge Inspections in the amount of \$106,300.00. Roll call: All ayes. Motion carried.

The commissioners had a few concerns from the public. One concern is about the road by Vogt's gravel pit, the wind row of gravel in the middle of the road needs to be smoothed out. Mr. Sund said the crew will go out and fix it. Another concern is Boerner/Mills Road needs to be bladed soon. The last concern is that when they clean out the culverts to make sure and bag all of the debris and trash and not leave it laying in the ditch.

Brad Jelinek has requested an approach that meets County guidelines. Novotny made the motion, seconded by Jorgensen, to approve the approach, with the County doing only the dirt work. Roll call: All ayes. Motion carried.

Commissioner Wilcox informed the commissioners and Mr. Sund he is still in contact with Yankton about sending 4 prisoners to help with road patching. They are going to come inspect the jail before committing to send them here to help with road patching. They would be here Monday through Friday.

Jamie Van Zee and Eric Putney from Brosz Engineering, Inc. and Jessica with KEA Construction entered the meeting at 12:50 P.M.

Commissioner Kartak and Wilcox asked Eric Putney to check into a Rural/Tribal Grant and a Safety Street and Road Grant to redo North County Road. Mr. Wilcox stated the SDDOT navigator has a Tool Kit that shows available grants.

At 1:00 P.M. the bid opening was held as advertised for BRF 6581 (00) 22-1 PCN 08XG. Roger Sund, Highway Superintendent, Jessica with KEA Construction and Jamie Van Zee and Eric Putney, Brosz Engineering, Inc., were in attendance.
