Mr. Pahlke explained to the commissioners that they will evaluate the documentation presented to them and determine whether they will amend their previous denial or reaffirm the denial of the Liquor License for Smoking Barrel's.

Kasey Oliver, Smokin Barrel's Attorney, presented documents showing that the establishment was open sixty days in 2022 and 2023.

Commissioner Kartak asked if she knew about the delinquent property taxes. Ms. Oliver said they were aware, but the address of the tax notice is not correct, so Mr. Calkins did not receive the notice.

Commissioner Wilcox asked if the establishment was open to the public those 60 days, as some of those days did not show any sales.

Commissioner Forgey asked what wholesaler the liquor is purchased from. Mrs. Calkins said they have a stock closet of liquor, but they normally purchase what they need from Jerome Wholesale in Mitchell and the Johnson Brothers in Sioux Falls.

The commissioners will discuss it further and make their decision and Mr. Pahlke will contact them.

Discussion was held on the evidence presented.

Jorgensen made the motion, seconded by Forgey, to affirm their previous decision to deny the Liquor License Renewal for Smokin Barrels, on account of additional information that the property owner failed to pay the property taxes at the time of the application.
