At 10:15 A.M. State's Attorney Pahlke and Deputy States Attorney Juracek left the meeting.

Mrs. Richey asked if she could attend the Spring Conference on April 12-14, 2024 and a 4-H online which is one day in Mitchell in April. Kartak made the motion, seconded by Jorgensen, to authorize the necessary expenses for Nicole Richey, Extension Secretary, to attend both conferences in April, 2024. Roll call: All ayes. Motion carried.

Mrs. Richey stated they no applicants for the cleaning of the 4-H building, but she is going to reach out to the 4-H leaders and have it in the next 4-H bulletin.

Discussion was held on Roger Sund, Hwy Superintendent, wages and if he needed a raise. There are concerns that with all the overtime the crew is getting they are exceeding Mr. Sunds wage as he is salary. It was a concern that the budget has already been approved and raises should be made before the approval of budgets, or they will exceed their budgeted amount.

At 10:22 A.M. Forgey made the motion, seconded by Jorgensen, to enter Executive session to discuss a personnel issue pursuant to SDCL 1-25-2 (1).

The Deputy Auditor, Marcia Haukaas, and Dan Bechtold, Winner Advocate, left during executive session.

At 10:30 A.M Doug Kinniburg with SSDOT joined the meeting via teleconference. Mr. Kinniburg discussed the counties options for loans or advancements from the state or federal government to help with the county share being \$1.2-million dollars and total cost for the project being \$5.8 million dollars on bridge work that is slated to be done in 2024.

- 1. Advancement in STP allocations, which we receive \$345,000 yearly. They could choose to do a couple year advancement in those payments. With matching funds, the county gets \$383,000 a year. If they decide to take advancement will not get the extra \$38,000 a year for the term of the advancement.
- 2. Federal infrastructure loans on any federal bridges are slated to be done in 2024.
- 3. Extended state highway loan which we would use the STP money as a promissory note.

Mr. Kinniburg stated that we are slated to start work on two replacement bridges and two federal bridge replacements. There are also a couple more slated to begin work in 2025. There is a possibility that we could push off the start date of the 2025 projects for 1 year depending on the type as Federal bridges only have 3 years to obligate funds. Along with that they would have to consult with the consulting firm on the possibility of these being pushed back.

Discussion was held on what the plan would be to produce the county share of the bridge work that is slated to begin this year. If necessary, a CD could be cashed in to help with the cost of the bridge work.

Discussion was held on what the highway crew has been doing.

Forgey made the motion, seconded by Novotny, to adopt the following:

**RESOLUTION (13-2024):** 

WHEREAS, Title23, Section 151, United States Code and Title23, Part 650, Subpart C, Code of Federal Regulations, requires initial inspection of all bridges and reinspection at intervals not to exceed two years with the exception of reinforced concrete box culverts that meet specific criteria. These culverts are reinspected at intervals not to exceed four years.

THEREFORE, Tripp County is desirous of participating in the Bridge Inspection Program using Bridge Replacement funds.

The County requests SDDOT to hire Brosz Engineering, Inc. (Consulting Engineers) for the inspection work. SDDOT will secure federal approvals, make payments to the Consulting Engineer for inspection services rendered, and bill the County for 20% of the cost. The County will be responsible for the required 20% matching funds.

The truck they were looking into purchasing after going to look at it in person the truck was rusted out and not worth purchasing, however, there is a truck in Wisconsin that would be worth looking into more. Commissioner Wilcox stated he would be willing to go and look at the Sterling truck. The asking price is \$47,600.00.

Mr. Sund stated that he is aware of some wrong signs that were put up by the state and they are to come down and go over all of them again and fix the ones that need to be fixed.

Discussion was held on CDL's and making it easier for employees to obtain them. They would come down and do the classes and test for the 2-day class. This runs \$130.00/hr. and would be 5 hours per day. If the county would pay for the testing and classes, the employee would have to agree to stay with the county for an extended period or repay the county for the classes and test.

Jorgensen made the motion, seconded by Kartak to adopt the following:

RESOLUTION (14-2024):

WHEREAS Tripp County recognizes that North County Road between Winner and Ideal is a highly traveled, critical component of the County's transportation system, and

WHEREAS Tripp County has identified the need to reconstruct North County Road due to its poor condition, and

WHEREAS Tripp County is eligible to apply for federal RAISE grant funds for the proposed reconstruction of North County Road.

NOW THEREFORE BE IT RESOLVED that the Tripp County Commission authorizes the Chair of the Tripp County Commission to sign and submit application documents for the RAISE grant application requesting 100% reimbursement for eligible project costs.

ALSO BE IT RESOLVED that Tripp County is committed to providing the balance of funds necessary to complete the project if there are any cost overruns.

Treasurer Candy Biggins, Assessor Janiece Weber, and Register of Deeds Kristin Assman entered the meeting. Discussion was held on the recommendation of redoing the handbook by Alternative HR. Job descriptions are too vague and need to be brought up to date. The commissioners decided to table the discussion on job descriptions and redoing handbooks. Mrs. Weber stated that she feels the heads of each office should be the ones to write the job descriptions for their offices as they know what is done or needs to be done better than someone outside the office. She also stated that it would be nice to have a starting wage listed so there is a set wage for each position. The commissioners felt that this would be a good idea for the heads to bring in a list of job duties and to reach out to other counties for a pay scale and come in with a starting wage for each position. After the commissioners review each job detail and starting wage, they will then either approve it, add to the duties, or deny it. Once all has been reviewed, they will start redoing the handbook.
