Mr. Mauck explained with the new weight limit of the trucks, they would double their trips to Pukwana to unload and this will be a cost increase to their customers. Mr. Mauck is also concerned that the new bid is for 2 years instead of 5 years and is concerned that in 2 years the city will then have their own garbage pickup.

Troy Krueger, Public Works Director, said the smaller trucks are a must to protect the streets in Winner. Mr. Krueger explained there will be three options to choose from in the bid specifications.

Jody Brozik, Winner City Mayor, explained the three bid options that will require the smaller trucks. The first is a similar service where the awardee will own their own totes, dumpsters, and they will transfer garbage to Pukwana.

The second is that the awardee will collect the trash and take it to the Transfer Station at no cost. The third is the totes and dumpsters will be owned by the city.
