Tripp County, South Dakota May 23, 2023

The meeting of the Tripp County Commissioners was called to order by the Chair in the Commissioner Room at the Court House at Winner on May 23, 2023 at 10:00 A.M. Roll call showed Board members Joyce Kartak, Daniel Forgey, Cody Jorgensen and Michael Novotny. Absent was Larry Wilcox. Also present was Auditor Barbara DeSersa, Zane Hamiel and Kathie Cole, Ambulance and Dan Bechtold, Winner Advocate.

Novotny made the motion, seconded by Forgey, to add discuss accumulative vacation hours and approve the agenda as amended.

No conflict of interest was reported.

No one appeared for public comment.

Kathie Cole, Ambulance Director, came to the meeting to discuss an ambulance surplus or two. The county currently owns 6 ambulances. Ms. Cole would like to surplus the 1997 ambulance and a 2013 ambulance that is currently located in Colome, which will be replaced with a different ambulance. Novotny made the motion, seconded by Jorgensen, to surplus the 1997 and 2013 ambulances and advertise for sealed bids.

Roll call: All present ayes. Motion carried.

At 10:10 Commissioner Larry Wilcox and Paul Schueth, EMT, entered the meeting.

Mr. Schueth gave an update on the EMS SAMHSA Grant. There were 49 West River students that participated in the class and 17 of those were High School students. There were 14 students that participated in the practical portion of the course here in Winner. Mr. Schueth is very pleased with the program.

Duane Wetzel, Weed Supervisor, came to the meeting to discuss hiring summer help next year to cut down and remove the dead trees in the county right of way. Discussion was held about hiring someone this year. Forgey made the motion, seconded by Jorgensen, to give Mr. Wetzel permission to hire seasonal help, at least sixteen years of age, to cut and remove trees for \$15 per hour. Roll call: All ayes. Motion carried.

Oakley Perry, Program Manager, 4-H County Operations and Professional Development, and Mandy Stady, State 4-H Director, entered the meeting. Commissioner Kartak asked Mr. Perry to come to the meeting to explain to the other commissioners the changes needing to be made in the Tripp County Extension Office moving forward.

Mr. Perry explained that finances for 4-H clubs should not be managed through the extension office, nor should the secretary handle money for workshops or write checks for these other entities. The Extension Secretaries role, according to SDSU, is to be a support role for the Youth Program Administrator. SDSU is currently advertising hiring a Youth Program Administrator for Tripp and Gregory County. Mr. Perry claims there were too many extra duties being done out of the extension office that did not pertain to 4-H and the 4-H Clubs should be the ones organizing the Mid-Dakota Fair.

4-H Leaders Kim DeMers, Dawn Covey, Scott Hollenbeck, Heather Heying and Nicole Brinda asked to come to the meeting to clarify some things that have been said. Kim DeMers explained that the Tripp County Extension Office has been used as a drop off location for the 4-H Leaders for many years. It is easier to have a central drop off location for sponsors that are donating money to the many programs that the Leaders fund for the 4-H programs. Dawn Covey explained that all fund raising the 4-H Leaders do is to pay for the awards, ribbons, judges, workshops, and 4-H recognition night. Mrs. Covey also explained that the county budget for the extension office pays for the secretary's wage, benefits, SDSU YPA and a few supplies. These five members of the 4-H Leaders all discussed their passion for 4-H and their years of volunteering to keep the program active in Tripp County. Mrs. Covey said there should be a 3-way partnership between the State, County and Leaders for the 4-H Program. Mrs. Covey would like to see the Commissioners allow Nicole Richey, Extension Secretary, the opportunity to reach out to Debbie Steinke, with her questions if needed and Mrs. Steinke should be compensated for her time.

Mr. Perry said 4-H is a program of the state and not the county. The state has rules, and one isn't to allow money to be exchanged in the extension office for other entities and any 4-H entity must abide by the state rules. Mr. Perry explained that this is a risk and a liability to the state 4-H program. A discussion was held having a drop box in the extension office and Mr. Perry will allow that if the county employee does not process the money. Joyce Kartak said she will talk to Nicole and Debbie about training. Mr. Perry said the extension secretary in Gregory County is coming to mentor Nicole Richey. Mr. Perry, Stady and 4-H Leaders left the meeting.

Bonnie Rutten and Barb Watzel, 4-H Leaders entered the meeting to say they thought Mrs. Steinke had overstepped her boundaries and they are glad to hear there will be a drop box in the Extension Office. They also agreed that the committees should run the fair.

Greg Henderson, District III Representative, came to the meeting to give the Planning & Development District III 2022 Performance Report.

Robert Tate and Deb Kendrick entered the meeting. Mr. Tate wanted to discuss eminent domain and the CO2 Pipeline in South Dakota. Mr. Tate would like each Commissioner individually to write a letter to the PUC opposing the grant for the CO2 Pipeline in South Dakota. Eminent domain is for private gain only.

John Harter joined the meeting. Mr. Harter's concerns are for the rights of the personal property owners. Discussion was held.

Jamie Van Zee and Eric Prunty, Brosz Engineering Inc, and Roger Sund, Highway Superintendent, entered the meeting. Mr. Van Zee came to the meeting to tell the Commissioners that the following projects 306th Ave. Structure Replacement Project, BRF 6581(00)22-1, PCN 08XG, and 318th Ave. Structure Replacement Project, BRO 8062(00)22-2, PCN 08XH is to be awarded to the lowest Bidder Prahm Construction Inc., contingent upon South Dakota Department of Transportation approval.

Forgey made the motion, seconded by Jorgensen, to award both Structure Replacement bids to the lowest Bidder Prahm Construction Inc., contingent upon South Dakota Department of Transportation

Mr. Prunty discussed the cost analysis for the North County Road project that will be submitted for the Raise Grant when it is available. Discussion was held.

Mr. Prunty also asked about the Agribusiness Grant on 317<sup>th</sup> Ave that was denied. Mr. Prunty asked if the commissioners want to submit it again.

Fogey made the motion, seconded by Jorgensen, to apply for the Agribusiness Grant on 317<sup>th</sup> Ave. Roll call: All ayes. Motion carried.

Wade Iszler, RDO, came to the meeting to bring proposals for a new John Deere grader. The options were discussed but no decision was made.

Roger Sund, Highway Superintendent, gave his report. The crews are blading roads, repairing signs, hand patched oil road projects 6139S-6139N-6132-6302 and repaired a washout by a culvert on project 43. Mr. Sund brought a timeline on the repairs on the Witten Bridge. Zachary Pahlke, States Attorney, entered the meeting.
